RSA 270:76 - No person shall use or operate any motorboat or boat equipped with an outboard motor on the waters of Abbott Forest Pond in Stoddard.

Adder Pond/Hopkins Pond - Andover

SAF-C 402.34 - No person shall operate a motorboat on Hopkins Pond in Andover.

Angle Pond - Hampstead/Sandown

RSA 270:74-a - Skcraft banned 10/01/90.

Arlington Mill Reservoir - Salem

RSA 270:74 - Skcraft banned 10/01/88.

Armington, Lake - Piermont

RSA 270:74-a - Skcraft banned 12/07/89.

Ashuelot, Lake - Washington

RSA 270:74-a - Skcraft banned 11/01/90.

Boat/Motor restriction - contact Keene for regulations. Public water supply.

Back Lake - Pittsburg

SAF-C 402.01 - No person shall operate a motorboat at a speed exceeding 10 MPH. However, this restriction shall not apply between 12:30 and 3:30 p.m. daily on that portion of Back Lake in Pittsburg easterly of a line running from Washburn's Camp on the south to the New Hampshire Guide's Lot on the north.

RSA 270:74-a - Skcraft banned 10/01/04.

Baptist Pond - Springfield

RSA 270:74-a - Skicraft banned 12/31/89.

Bear Pond - Alton

SAF-C 402.02 - No person shall operate a motorboat on Bear Pond in Alton.

Boat/Motor, seaplane restriction - contact Contoocook/Hopkinton for regulations.

Bearcamp Pond - Sandwich

RSA 402.03 - No person shall operate a motorboat at a speed exceeding 10 MPH on Bearcamp Pond in Sandwich.

Beaver Lake - Derry

Saf-C5102.04- (a) No person shall operate a boat at a speed exceeding 10 miles per hour on Beaver Lake in the town of Derry. This restriction shall not apply between the hours of 1:00 p.m. and 7:00 p.m. daily, and further provided that during unrestricted hours no boat shall exceed 30 miles per hour at any time. (b) All water skiing on Beaver Lake shall be in a counterclockwise direction at all times.

Bellamy Reservoir - Barrington/Dover/Madbury

Boat/Motor, Seaplane restriction - contact Portsmouth for regulations. Public water supply.

Belleau Lake - Wakefield

Boat/Motor restriction - contact Rochester for regulations. Public water supply.

Berry Pond - Moultonborough

RSA 270:85 - No person shall use or operate any motorboat or boat equipped with an outboard motor on Berry Pond in Moultonborough.

Berry Pond - Pittsfield

Seaplane restriction - contact Pittsfield for regulations. Public water supply.

Berry's River Watershed - Rochester

Boat/Motor restriction - contact Rochester for regulations. Public water supply.

Big Brook Bog (Pond) - Pittsburg

SAF-C 402.05 - No person shall operate a motorboat on Big Brook Bog in Pittsburg.

Big Cherry Pond - Jefferson

RSA 270:81 - No person shall use or operate any motorboat or boat equipped with an outboard motor on Big Cherry Pond in Jefferson.

Big Dan Hole Pond - Ossipee/Tuftonboro

RSA 270:74-a - Skicraft banned 12/31/89.

Big Island Pond - Derry

RSA 270:74-a - Skicraft banned 9/25/89

Big Pea Porridge Pond - Madison/Conway

RSA 270:93 - No person shall use or operate any powerboat equipped with an internal combustion engine on the open waters of Big Pea Porridge Pond in Madison and Conway.

Boundary Pond (Mountain Pond) - Pittsburg

SAF-C 402.06 - No person shall operate a motorboat on Boundary Pond in Pittsburg.

Bow Lake - Strafford

SAF-C 402.07 -(a) No person shall operate a vessel at a speed exceeding 6 MPH on that section of Bow Lake in Strafford between:

- (1) the dam at the outlet of the lake;
- (2) the easterly point of the first island west thereof, and
- (3) also on the northerly course between the easterly point of the island referred to in (2) and the red and black buoys marking the northwest entrance to the channel.

Bradley Lake - Andover

RSA 270:114 - No person shall use or operate any petroleum powered boat equipped with any type of petroleum powered motor in excess of 30 horsepower upon Bradley Lake in Andover.

Boat/Seaplane Restriction - contact town of Andover for regulation. Public water supply.

Brindle Pond - Barnstead

RSA 270:88 - No person shall operate any boat equipped with a petroleum-powered motor on Brindle Pond in Barnstead.

Butterfield Pond - Wilmot

SAF-C 402.08 - No person shall operate a motorboat on Butterfield Pond in Wilmot.

Camp Brook - Hanover

Boat/Motor restriction - contact Hanover for regulations. Public water supply.

Canaan Street Lake - Canaan

RSA 270:113 - No person shall use or operate a Skicraft as defined in RSA 270:73 V, or a hovercraft as defined in RSA 270:2, VIII, on the above mentioned lake.

Boat/Motor restriction - contact Canaan for regulations. Public water supply.

Canobie Lake - Salem

RSA 270:74-a - Skicraft banned 06/25/03

Boat/Motor, **Seaplane restriction** - contact Salem for regulations. Public water supply.

Cass Pond - Richmond

SAF-C 402.09 - No person shall operate a motorboat at a speed exceeding 10 MPH on Cass Pond in Richmond.

Cawley Pond - Sanbornton

SAF-C 402.10 - No person shall operate a motorboat on Cawley Pond in Sanbornton.

Center Pond - Nelson

SAF-C 402.11 - No person shall operate a motorboat on Center Pond in Nelson.

Cedar Pond - Milan

RSA 270:74a - Skicraft banned 07/25/00.

Chalk Pond - New Durham

RSA 270:101 - I. No person shall use or operate any powerboat equipped with any type of power motor in excess of 5 horsepower upon Chalk Pond in New Durham. II. No person shall use or operate jet skis on Chalk Pond.

Chestnut Pond - Epsom

SAF-C 402.12 - No person shall operate a vessel at a speed exceeding 10 MPH on Chestnut Pond in Epsom. However, this restriction shall not apply between 12:00 noon and 5:00 p.m. daily and all water skiing **shall** be conducted in a clockwise direction at all times.

Chocorua Lake - Tamworth

RSA 270:83 - No person shall use or operate any motorboat or any boat equipped with an outboard motor on Chocorua Lake in Tamworth.

Christine Lake - Stark

RSA 270:117 - No person shall use or operate any power boat equipped with any type of power motor in excess of 10 HP on Christine Lake in Stark.

Clarksville Pond - Clarksville

RSA 270:104 - No person shall operate any boat equipped with a petroleum-powered motor on Clarksville Pond in Clarksville. Any other type of motor used on Clarksville Pond cannot develop more than trolling speed.

Clement Pond (Joesylvia Lake) - Hopkinton

RSA 270:74-a - Skicraft banned 12/31/89

Cobbetts Pond - Windham

RSA 270:74-a Skicraft banned 12/31/89.

SAF-C 402.13 - That portion of Cobbetts Pond in Windham known as the Narrows, which extends 860 feet northeast from the boat ramp at 30 Horseshoe Rd to a stone wall on the point on the east side of the Pond shall be a no wake zone.

Cocheco River - Rochester

RSA 270:89 - No person shall use or operate a motorboat or any boat equipped with an outboard motor with a manufacturer's rated capacity in excess of 7.5 HP, or shall any person exceed a headway speed of 10 MPH with any powerboat equipped with an outboard motor on Cocheco River within the City limits of Rochester.

Coniston, Lake - Croydon

SAF-C 402.14 - The lower portion of Lake Coniston in Croydon shall be a "no wake" area.

Connecticut River - New Hampshire jurisdiction

RSA 270:115 - The department of Safety, division of Safety Services, shall post at all boat launching sites

on the Connecticut River, within the jurisdiction of the State, a speed limit of headway speed within 150 feet of the shoreline.

RSA 270:120 - I. Notwithstanding any other law to the contrary, no person shall use or operate any motorboat or any boat equipped with an outboard motor in excess of headway speed of 6 MPH upon the waters of the Connecticut River between the Ledyard Bridge in Hanover and a line across the river a distance of 2,500 feet to the north of the Ledyard Bridge.

II. No person shall operate a motorboat or any boat equipped with an outboard motor in the area described in paragraph I while towing a person, whether or not that person is using water skis, an aquaplane, or any other similar device.

III. The provisions of this section shall not apply to a motor boat or any boat equipped with an outboard motor that is used in the area described in paragraph I as follows:

- a. by state or town employees for patrolling the area;
- b. by any person in the case of an emergency rescue activity.
- c. by any person in connection with coaching of rowing; or
- d. by any person during boat personnel training and boat meets.

SAF-C 402.151 - No person shall operate a motorboat at a speed greater than headway speed upon the waters of the Connecticut River in the town of Westmoreland, from the property line of Tax Map R11, Lot 9, then proceeding south to the intersection of River Road and Partridge Book Road, representing a total approximate distance of 1,800 linear feet and extending from east to west across the Connecticut River to the opposite shoreline in the town of Westmoreland.

Connor Pond - Ossipee

SAF-C 402.15 - No person shall operate a boat equipped with a petroleum-powered motor and at greater than headway speed.

Contoocook Lake - Rindge/Jaffrey

RSA 270:74-a Skicraft banned 11/09/99.

Conway Lake - Conway

RSA 270:77 - No person shall at any time place in or upon, or use, or operate upon, Conway Lake, any houseboat.

RSA 270:74-a - Skicraft banned 10/01/89.

Cooks Pond (Kingswood Lake) - Brookfield

RSA 270:74-a - Skicraft banned 12/31/89.

Coon Brook Bog - Pittsburg

SAF-C 402.16 - No person shall operate a motorboat on Coon Brook Bog in Pittsburg.

Country Pond - Kingston

RSA 270:74-a - Skicraft banned 12/31/89.

Crescent Lake - Acworth and Unity

SAF-C 402.17 - All motorboats shall be operated in a counter-clockwise direction at all times.

RSA 270:74-a - Skicraft banned 10/01/05.

Crescent Lake - Wolfeboro

RSA 270:74-a - Skicraft banned 10/01/89.

Crystal Lake (Robertson Pond) - Eaton

SAF-C 402.18 - No person shall operate a motorboat with more than 10 horsepower on the waters of Crystal Lake in the town of Eaton. Crystal Lake, in the town of Eaton, shall be a "no wake" area.

Cunningham Pond - Peterborough

SAF-C 402.181 - No person shall operate a motorboat powered by gasoline, naphtha, or any other petroleum products on Cunningham Pond in Peterborough.

Cunningham Pond - Peterborough

PENDING FOR 2009 - No person shall operate any boat powered by any petroleum products on Cunningham Pond.

Deering Lake (Reservoir) - Deering

RSA 270:74-a - Skicraft banned 10/01/89.

Diamond Lake (Tom's Pond) - Warner

SAF-C 402.19 - No person shall operate a motorboat at a speed exceeding 10 MPH on Diamond Lake (aka Tom's Pond) in Warner.

Dole Reservoir - Claremont

Boat/Motor restriction - contact Claremont for regulations. Public water supply.

Dublin Lake - Dublin

RSA 270:74 - Skicraft banned 10/01/88.

SAF-C 402.20 - No person shall operate a motorboat at speed exceeding 10 MPH on Dublin Lake in Dublin. However, this restriction shall not apply between 4:00 p.m. and one-half hour after sunset daily.

Dudley Pond - Deering

SAF-C 402.21 - (a) No person shall operate a motorboat powered by gasoline, naphtha, or any other petroleum products on Dudley Pond in Deering. (b) This section does not prohibit boats powered exclusively by electric motors.

Duncan Lake - Ossipee

RSA 270:109 - No person shall operate any power boat at a speed exceeding 6 MPH on Duncan Lake.

RSA 270:74-a - Skicraft banned 12/31/89.

SAF-C 402.22 - No person shall operate a motorboat at a speed exceeding 10 MPH on Eastman Pond in Grantham.

Hampton/Seabrook Estuary - Hampton, Hampton Falls, Seabrook

RSA 270:74-a - Skicraft banned from the salt marshes of the Hampton/Seabrook Estuary with operation prohibited within three hundred (300) feet of any saltmarsh bank, berm, salt pond, creek, or river that flows through the salt marshes of Hampton, Hampton Falls and Seabrook, NH. Effective 06/25/07.

Everett Lake (Clough State Park) - Weare

SAF-C 402.23 - No person shall operate any boat powered by gasoline, naphtha or any other petroleum products on Everett Lake (Clough State Park) in Weare.

Ferrin Pond - Weare

SAF-C 402.24 - No person shall operate a motor boat on Ferrin Pond in Weare.

RSA 270:128 - No person shall use or operate a boat equipped with a petroleum-powered motor on Flint Pond in Hollis. Use of electric motors with a manufacturer's rated capacity not in excess of 3 HP is authorized, and no person shall exceed a headway speed of 5 MPH on Flint Pond.

Folletts Brook - Newmarket

Seaplane restriction - contact Newmarket for regulation. Public water supply.

Forest Lake - Winchester

RSA 270:74-a - Skicraft banned 10/05/99.

Forest Pond - Whitefield

RSA 270:74 - Skicraft banned 10/01/88.

French Pond - Henniker

SAF-C 402.25 - No person shall launch or operate any powerboat or watercraft on French Pond in Henniker with any type of power motor in excess of 5 HP.

Frost Pond - Jaffrey/Dublin

SAF-C 402.26 - No person shall operate a motorboat at a speed exceeding 10 MPH on Frost Pond.

Seaplane restriction - contact Lancaster for regulations. Public water supply.

Garland Pond - Moultonborough

RSA 270:123 - No person shall use or operate a boat or any other watercraft equipped with any type of power motor, except an electric motor not in excess of 5 HP on Garland Pond in Moultonborough.

Gilman Pond - Alton

SAF-C 402.27 - No person shall operate a motorboat on Gilman Pond in Alton.

Gilman Pond - Unity

Boat/Motor, Aircraft restriction. Contact Newport for regulation. Public water supply.

Gilmore Pond - Jaffrey

RSA 270:74-a - Skicraft banned 10/01/90.

Saf-C 402.28 - Gilmore Pond shall be a "no wake" area.

Glen Lake - Goffstown

RSA 270:74-a - Skicraft banned 12/31/89.

Godfrey Dam - Upper Ammonusuc River - Berlin

Seaplane restriction - contact Berlin for regulation. Public water supply.

Goffstown Reservoir - Goffstown

Seaplane restriction - contact Goffstown for regulation. Public water supply.

Goose Pond - Hanover/Canaan

RSA 270:74-a - Skicraft banned 12/31/89.

Saf-C 402.29 - The part of Goose Pond, in the town of Canaan, and so-called The Narrows, and extending 150 feet from the boating and swimming area from the northern most point of lot 1-GS-49 and southwest to lot 1-GS-47 on the western shore shall be a no wake area.

Goose Pond - Keene

RSA 270:125 - No person shall use or operate a boat or any other watercraft equipped with any type of power motor on Goose Pond in the city of Keene.

Gorham Pond - Dunbarton

RSA 270:74-a - Skicraft banned 12/31/89.

Gould Pond (Emerald Lake) - Hillsborough

SAF-C 402.30 - No person shall operate a motorboat at a speed exceeding 10 MPH on Gould Pond.

Grafton Pond - Grafton

RSA 270:95 - No person shall use or operate any power boat equipped with any type of motor in excess of 6 HP on Grafton Pond in Grafton.

Saf-C 402.301 - No person shall operate any boat powered by any petroleum products on Grafton Pond.

Granite Lake - Stoddard

RSA 270:74 - Skicraft banned 10/1/88.

Gregg Lake - Antrim

RSA 270:74-a - Skicraft operation restricted to "no greater than headway speed" in the portion starting in the area known as the Meadows and extending to the area known as the Narrows, extending to a point approximately 500 feet south of Camp Birchmere effective 8/30/89.

SAF-C 402.31 - (a) Motorboats shall be limited to 150 HP or less on Gregg Lake.

(b) All water skiing on Gregg Lake shall be in a counter-clockwise direction at all times.

Boat/Motor restriction - contact Hanover for regulations. Public water supply.

Harrisville Pond - Harrisville

RSA 270:74 - Skicraft banned 10/1/88.

Hawkins Pond - Center Harbor

Saf-C 402.32 - No person shall operate a motorboat of more than 8 HP on Hawkins Pond in Center Harbor; further, motorboats shall not be operated at a speed exceeding 10 MPH.

Head's Pond - Hooksett

RSA 270:131 - No person shall use or operate any watercraft, as defined in RSA 270:73 (skicraft), or powerboat equipped with a gas-powered internal combustion engine on the open waters of Head's Pond in Hooksett. The use of electric-powered motors is authorized.

Hermit Lake - Sanbornton

RSA 270:103 - No person shall use or operate any power boat equipped with any type of power motor in excess of 10 HP on Hermit Lake in Sanbornton.

Highland Lake - East Andover

RSA 270:74-a - Skicraft banned 12/31/96.

Honey Pot Pond - Amherst

SAF-C 402.33- (a) No person shall operate a motorboat powered by gasoline, naphtha or any other petroleum products on Honey Pot Pond in Amherst. (b) This section shall not prohibit the operation of boats powered exclusively by electric motors.

Hopkins Pond - Andover

SAF-C 402.34 - No person shall operate a motorboat on Hopkins Pond in Andover.

Horseshoe Pond - Merrimack

SAF-C 402.35 - No person shall operate a motorboat at a speed exceeding 10 MPH on Horseshoe Pond in Merrimack.

Hot Hole Pond - Concord

SAF-C 402.351 - Hot Hole Pond, in the town of Loudon and the city of Concord, shall be a "no wake" area.

Hunkins Pond - Sanbornton

SAF-C 402.36 - No person shall operate a motorboat on Hunkins Pond in Sanbornton.

Upper Shield Pond (Rainbow Lake) - Derry

SAF-C 402.84 - No person shall operate a motorboat at a speed exceeding 6 MPH on Upper Shield Pond in Derry.

Wakondah Pond - Moultonborough

RSA 270:99 - No person shall use or operate any powerboat equipped with an internal combustion engine on the open waters of Wakondah Pond in Moultonborough. Electric motors are authorized.

Walker Pond - Boscawen and Webster

SAF-C 402.85 - Motorboats shall be limited to 6 HP or less on Walker Pond.

Warren, Lake - Alstead

RSA 270:74-a - Skicraft banned 10/29/98.

Washington Lake (Island Pond) - Washington

RSA 270:74-a - Skicraft banned 10/01/89.

Waukeena Lake - Danbury

RSA 270:111 - No person shall use or operate any boat equipped with a petroleum powered motor on Waukeena Lake in Danbury.

Waukewan, Lake - Meredith

RSA 270:74-a - Skicraft banned 12/31/89.

Boat restriction area of water intake - contact Meredith for regulations. Public water supply.

Wentworth, Lake - Wolfeboro

RSA 270:74-a - Skicraft banned 10/01/90.

Wheelwright Pond - Lee

RSA 270:74-a - Skicraft banned 10/01/98.

White Mountain National Forest

RSA 270:29 - It shall be unlawful to operate a boat or canoe propelled by mechanical power on any stream or body of water within the boundaries of that part of the White Mountain National Forest that is situated within the State of New Hampshire. The provisions of this section shall not apply to the following bodies of water:

Stinson Lake - Rumney

North & South Percy Ponds - Stark

Kimball Pond - Chatham

Long Pond - Benton

Nor to persons engaged in emergency rescue operations or public service.

White Oak Pond - Holderness

RSA 270:94 - No person shall use or operate any motorboat or any boat equipped with an outboard motor in excess of 7.5 HP on White Oak Pond in Holderness.

Saf-C 402.86 - Seaplanes and helicopters on floats shall be prohibited from operating on White Oak Pond in the town of Holderness, except for the purpose of landing and taking off, pursuant to RSA 270:13a.

White Pond - Ossipee

RSA 270:109 - No person shall operate any powerboat at a speed exceeding 6 MPH on White Pond.

White's Pond - Wilmot

SAF-C 402.87 - No person shall operate a motorboat on White's Pond in Wilmot.

Whitewater Brook - Cornish/Claremont

Boat/Motor restriction - contact Claremont for regulations. Public water supply.

Whittemore, Lake - Bennington

RSA 270:76 - No person shall use or operate any motorboat or boat equipped with an outboard motor on Lake Whittemore in Bennington.

Whittle Brook - Goffstown

Seaplane restriction - contact Goffstown for regulations. Public water supply.

Wicwas, Lake - Meredith

RSA 270:74-a - Skicraft banned 11/01/89.

Wild Goose Pond - Pittsfield

RSA 270:74-a - Skicraft banned 10/01/89.

Willand Pond - Somersworth/Dover

RSA 270:112 - No person shall operate any vehicle or boat equipped with an internal combustion engine on the ice or open waters of Willand Pond in Somersworth and Dover.

Willard Pond - Antrim

RSA 270:82 - No person shall use or operate any boat equipped with a petroleum powered motor on Willard Pond in Antrim.

Wilson Lake - Salem

RSA 270:119 - The use of petroleum powered boats is prohibited on Wilson Lake in Salem.

Winnepesaukee, Lake - Lakes Region

RSA 270-D, X - Speed limit of 45 mph during daylight hours and 30 mph during the period from ½ hour after sunset to ½ hour before sunrise. (See Revised Statutes Annotated, RSA 270-D - General Rules for Vessels Operating on Water, subsection X, for complete statute)

RSA 270:74-a - Blackkeys Cove, Salmon Meadow Cove, Green's Basin. Skicraft banned 12/01/89.

RSA 270:74-a - Cedar Cove. Skicraft banned 10/31/96.

RSA 270:74-a - Skicraft banned in the cove west of Bear Island defined by an imaginary line running south from Jerry Point on Bear Island to the western most point of Rock Island to the western most point of Shepard Island to the southwest tip of Bear Island. Effective date 10/23/98.

RSA 270:74-a - Pickerel Cove - speed limit for skicraft - 08/23/02.

SAF-C 402.88 (a)- (av) - Numerous "NO WAKE" zones which can be identified on a Navigational Chart of Lake Winnepesaukee.

SAF-C 404.10 - Back Bay Channel, Wolfeboro, all vessels leaving Back Bay Channel shall have the right of way from all vessels, except for canoes, rowboats and sailboats, pursuant to RSA 270-D:2, IX, entering the channel.

SAF-C404.11 - Weirs Beach Restriction - There may be temporary restrictions on anchoring, mooring and/or rafting in the Weirs Beach area should the Commissioner of Safety determine that such restriction shall be implemented. If such a restriction is implemented, the Commissioner shall issue public notice through a press release to print, radio and television media at least three days prior to the effective date which will include effective date and time of restriction, ending date and time of restriction, reason for restriction and description of area to be restricted.

SAF-C 407.03 - Rafting as defined in RSA 2760:42 V shall be prohibited in the following areas of Lake Winnepesaukee unless covered by one of the exceptions specified in RSA 270:45: (1) The Kona Mansion, so called, in Moultonborough, east of an imaginary line running north and south from the red top marker buoy located on the western tip of Avery's Point on the south to the Kona Farm gas docks on the north.

(2) Small's Cove in Alton, southwest of an imaginary line running southeast northwest from the light 75 on the northwestern end to the northernmost point of land marking the entrance to the first cove, south of Small's Cove on the south.

(3) Wentworth Cove, southwest of Governor's Island Bridge west of an imaginary north-south line, running from light 43 on the north to the black top buoy located off Wentworth Cove Estates on the south.

(4) Braun Bay - There shall be no rafting within 300 feet of both fish and game property lines as delineated by Marine Patrol with orange mooring balls.

Boat Restriction - area of Paugus Bay - contact Laconia for regulations. Public Water Supply

(5) Braun Bay at a distance less than 75 feet from shore lines as delineated by Marine Patrol with orange mooring balls.

(6) Cedar Cove, specifically identified as the area opposite Plum Island which borders Alton tax map 18, lot No. 12 through 20 and 55.

(7) Winter Harbor from the southern boundary of the Tuftonboro tax map 63, lot No. 14 to the southern boundary of tax map 51, lot No. 20.

(8) The entire area known as Green's Basin, in the town of Moultonborough.

(9) Orchard Cove, on the east side of Cow Island, in the town of Tuftonboro.

(10) The entire area known as Buzzell Cove, in the town of Moultonborough.

(11) Brickyard Cove, encompassing a described area that would run south of an imaginary line running about 2,300 feet from the northern tip of Lay Point to the southern tip of Barndoor Island.

(12) The entire area known as Black Cove, in the town of Meredith, encompassing an area in Meredith tax map S-7, east from the northern most point of Lot 5-1 to the southeastern most point of Lot 1.

(13) The entire area known as East Cove, in the town of Moultonborough.

(14) The entire area known as Advent Cove, in the town of Meredith.

(15) PENDING FOR 2009 - Roberts Cove in the town of Alton Boat Restriction - area of Paugus Bay - contact Laconia for regulations. Public Water Supply.

(15) Roberts Cove, in the town of Alton, encompassing a described area as between the body of water in Roberts Cove, east of a line running north to south from the westerly boundary of lot 41 on tax map 48 to the westerly boundary of lot 1 on tax map 48.

Winnipocket, Lake - Webster

RSA 270:74-a - Skicraft banned 10/01/89.

SAF-C 402.89 - No person shall operate a vessel at a speed exceeding 10 MPH on that section of Lake Winnipocket in Webster north of a line running between Austin's Point on the west to the cottage presently owned by Clinton Frothingham on the east. However, this restriction shall not apply between 12:30 p.m. and 3:30 p.m. daily.

Winnisquam, Lake - Lakes Region

SAF-C 402.90 (a) No person shall operate a vessel at a speed exceeding 6 MPH from the flashing light beacon on the westerly end of Mohawk Island to a point 400 feet northerly thereof.

(b) No person shall operate a vessel at a speed exceeding 6 MPH in the Winnisquam River so called, in the city of Laconia east of the light at Dixon Point.

(c) The area from Mosquito Bridge south to the flashing light beacon on the westerly end of Mohawk Island in Lake Winnisquam is a NO WATERSKIING area.

(d) The area on Lake Winnisquam that measures 700 feet north of Mosquito bridge to 150 feet south of Mohawk island shall be a no wake area.

Winona, Lake - Center Harbor/New Hampton

RSA 270:74-a - Skicraft banned 12/31/89.

Woodward Pond - Nelson/Roxbury

Boat/Motor restriction - contact Keene for regulations. Public water supply.
